Deduction of Advance Income Tax

The Government has ordered through its Finance Act 2013, under section 2361 in the Income Tax Ordinance 2001, to collect Advance Tax at rate of 5% on the amount of fees paid to the educational institutions, from the parent/ guardian of the students. (The said tax amount shall be adjustable against the tax liability of either of the parents or guardian making payment of the fees.) Hence the parent/ guardian shall also pay Advance Tax @ 5% on all the fees and charges paid for the students. Due to legal obligation of the College to collect and deposit the said amount of Tax to the Tax authorities.

Procedure for Payment of Fees

- a) All payments shall be made through Bank Draft / Pay Order in favour of the Principal, Cadet College Khairpur, or may be deposited in Bank Account through Fee Voucher.
- b) The fee will be paid in 02 tranches. However, in case of any compulsion the quarterly instalments will be made as per the approval of competent authority.
- c) FEE, EXCEPT THE SECURITY DEPOSIT, ONCE PAID, SHALL NOT BE REFUNDED UNDER ANY CIRCUMSTANCES.
- d) <u>Late Payment of Fees</u>: If dues are not received within due date, the cadets shall be fined at the rate of Rs.20/ per day for the first month of the term and the defaulter cadet's name could be struck off the College rolls.
- e) **Non-Payment of Dues**: If dues are not fully cleared, the defaulting cadet's forms for Board Examinations shall not be forwarded to the Board. Even if the form has been dispatched, the cadet concerned will not be allowed to appear at the annual examination, unless his fee account has been completely settled.
- f) <u>College Leaving Certificate</u>. The cadet's seeking admission in this College are expected to stay in the institution till the final stage (HSC Part-II) exam. Therefore, the cadet's asking for School Leaving Certificate/ Migration Certificate before completion of their H.Sc., shall have to pay discontinuation charges of Rs. 25,000/- and full fees for the current session (Three Months) in which cadet's applies for discontinuation, even if applied during vacations / term breaks etc.
